Explanation of Responses:

- The Series A Convertible Preferred Stock is convertible into Common Stock on a 7.4730-for-1 basis into the number of shares of Common Stock as shown in Column 3 at any time at the holder's election, and automatically upon the closing of the Issuer's initial public offering without payment of further consideration. The shares have no expiration date.
- This option to purchase a total of 115,080 shares was granted on June 28, 2017. The shares underlying the option vested with respect to 25% of the shares on January 17, 2018 and the remainder are scheduled to vest in equal monthly installments through January 17, 2021.
- This option was granted on June 20, 2019. The shares underlying the option are scheduled to vest in equal monthly installments through June 20, 2023.
- This option was granted on December 12, 2019. The shares underlying the option are scheduled to vest with respect to 25% of the shares on January 1, 2021 and the remainder are scheduled to vest in equal monthly installments thereafter through January 1, 2024.
